## Lee Lancon – Lancon Engineers, Inc.- Engineer Report

- Water Storage Tank Rehab (Phase 2) see engineers report
  - o Dallas Green (Phoenix CEO) took over the project for Michael.
  - Phoenix's subcontractor, Weiser Construction, began mobilizing today for GWST#1. Work starts on Monday, November 18, 2024. Work schedule is attached.
  - During design, initial thoughts were to eliminate roof stiffeners. Detailed structural design will require stiffeners for required wind loading. Lee has discussed with them about calculating with the channel installed so it is free draining.
  - Lee and Zack (Well Hung Metal), met with Hermillo (Weiser Construction) to coordinate how to handle the painting/covers on the filters.
  - The current schedule extends beyond the 210 days in the contract. Lee will discuss with Phoenix.
- Water Storage Tank Rehab (Phase 1)
  - Work was not completed today as expected. Should be completed tomorrow. Contractor will be flushing out the bottom and will finish buttoning the tank up depending on the weather.
  - Kent asked Lee about EWST# 2 (Mosswood). Lee stated he spoke with Greg Weiser. They indicated they are interested in doing the work. Once EWST#1 is back in service, Lee will coordinate with Jay to take EWST#2 out of service for inspection. Lee would like Wiser Construction to look at it and give a price on repairs that may need to be made. Lee plans to have Travis (Elite 360) accompany him on the inside for the inspection.
